While the end of September was rapidly approaching, even I was accepting the idea that 700,000 signatures would have not been reached by then. Actually, I had started to consider over 650,000 as a good result to feel better. But amazing things were behind the corner.

Our friends at PMAF suddenly communicated the shipping of tens of thousands of signatures, abundantly breaking both the 700,000 wall and the French target. A huge MERCI to them.

This means that we all have less to do to reach the million signatures... a good reason to speed up the collection.

Please get in touch with me about your plans, especially on the lobby side where confusion can be very harmful. We will be very happy to assist, and other groups can also help you develop your lobby plans if necessary.

Please carry on sending the signatures collected on paper from time to time, and **remember to correct the deadline on the forms on your websites into 4**th **November** if you haven't done it yet.

Signatures

In this moment (12.14 on 3 October) we have **756,197** signatures on the 8hours website, **5,052** on Change.org and **4,412** signatures on Firmiamo.it.

This brings the total so far to 765,661 !

The 4 November deadline is only one month away. We are free to postpone it if necessary, but we are really not far from the million signatures if we all make an extra effort.

As usual, the country breakdown of the next two pages includes signatures on www.8hours.eu only .

Please collect signatures on paper forms and postcards too, and please send the signatures you already have from time to time, to facilitate the counting at the office (and see numbers go up on the website!).

The main highlight for the last few days are the 106,000 more signatures from France, but here is some more good news:

- Germany: +7,500 - Italy: + 3,500 - Austria: + 2,000 - Spain: + 1,000

MEP support

- This is the natural and essential next step of the 8hours campaign. The million signatures we are collecting will be wasted if we don't use them to achieve permanent legislative change.
- The best option to contact MEPs is that people from their country speak to them and ask for their support. If that doesn't happen we will do it in different ways, but please realise that your help for this is extremely valuable.
- If you don't have previous experience of lobbing Members of the European Parliament, don't worry. Just get in touch with me and you will get all the advice you need to act in a simple and effective way.
